Goldsmith Williams is one of the largest solicitors firms in the UK specialising in property conveyance. With over 20 years of experience in this sector and hundreds of employees, Goldsmith Williams is on the panel of every leading bank, building society and centralised lender. ## **Business Problem**

Committed to modern management methods and the provision of high quality service, Goldsmith Williams have invested heavily in the latest technology and were one of the first firms to be awarded BS5750 Kitemark and ISO 9001 certification. As a solicitor firm, the nature of their daily work requires high volume printing. To ensure high quality printing which meets the needs of their clients and a smooth workflow, Goldsmith Williams uses a large printer fleet, which confronted the firm with the following challenges:

- A consumables budget which increases annually.
- Management has no way of seeing or managing how printers are utilised and find it impossible to accurately determine the cost of printing for each user and printer.
- It is difficult to create and enforce any Corporate Policy on printers.
- An increasing adverse impact on the environment at a time when staff and clients are increasingly environmentally conscious.

Maria Rodman, the firm's administration manager, recognised the above issues and was especially concerned over the magnitude of her consumables budget and the lack of print management information. When Maria was approached by John McDonald the TLS Sales Director [Preton Distributor for UK and Ireland] she decided it was well worth further investigation and decided to set up a full test which would allow them to categorically prove the level of the savings.
